AVERAGES

Bowlers must use **highest** USBC standard or adjusted sport league average for the 2010-2011 season (21 games or more in one league).

Bowlers with no previous season average shall use their current average as of 1st date of bowling. (21 games or more in one league) All others will bowl scratch.

Bowlers are responsible for verifying their own average, whether submitted by the bowler, team captain or others.

In the case of a team of 2 or more bowlers, the averages shall be combined to determine if the correct total is higher or lower than the submitted total.

If their submitted average is lower than required and results in a lower classification or more handicap, the bowler's score is disqualified. If the submitted average is higher than required, prize winnings will be based on the submitted average.

Corrections in average can be made up to the end of the 1st game of the series, or within 48 hours after the end of a series if the tournament manager, prior to the finish of the 1st game of the series, has given consent authorizing such extension.

AVERAGE ADJUSTMENT

10-pin average increase rule WILL be in effect.

Winnings of \$600 or more in any tournament in the past 12 months, must be reported at time of entry

Re-rating Rule 319e shall apply to all bowlers
If a bowler's accumulated tournament average, during the past 12 months for all, but not less than 21 games, exceeds the entering average by 15 or more pins, the accumulated tournament average must be used.

PARTICIPATION

Team Event – Multiple Entries Allowed with a Change of Two Players.

Doubles Event – Entry Limited to One Time.

Opt. Singles – Multiple Entries Allowed - Cash Once.
(Individual Team Score with Handicap)

Opt. All Events – Entry Limited to One Time.
(1st Team Score & Doubles Score with Handicap)

PRIZE PAYOFF

All Prize Money Returned 100%.

Prorated on number of entries.

Payback Ratios

Handicap Team, Doubles and Singles - 1 for 4

Optional Scratch Team, Doubles - 1 for 6

Optional All Events - 1 for 10

HANDICAP/SCRATCH

Scratch: Team - 880, Doubles – 440

Opt. Singles & All Events - 220

Handicap: 90% – No Limit.

FORFEITURES

Bowlers failing to appear at scheduled time will forfeit all money unless they can be rescheduled.

Bowlers arriving late will receive 0 for all frames missed.

Forfeiture of entry fees and prizes will follow disclosure of any violation of USBC tournament rules.

BRACKETS

Handicapped Brackets will be conducted each shift.

Proceeds used for Champions Awards, Banquet of Champions Dinners and to offset expenses.
