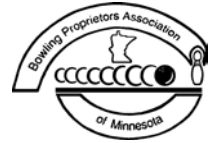

1. ELIGIBILITY

All bowlers must be ADULT WOMEN members of the St. Paul USBC Association.

Eligible non-members of the St. Paul USBC Association and who are not members of another Association, may purchase a USBC Associate Membership (\$16.00) prior to competition.

Eligible non-members of the St. Paul USBC Association and who are members of another Association, may participate in this tournament by purchasing a Local Association Membership (\$5.00) prior to competition, plus the State Membership of \$1.00 if applicable.

Failure to have membership shall result in disqualification and forfeiture of all entry fees and prize winnings.

2. AVERAGES

Highest Standard or Adjusted Sport League Average Shall Be Used

All certified averages will be used in the following order:

- A. The highest **2008-09** average (any association), based on a minimum of **21** games.
- B. The highest **2009 Spring** average based on a minimum of **21** games.
- C. The highest **current** certified league average as of the first date of participation, based on a minimum of **21** games.
- D. All others will use a 210 scratch average.

Rule 319A2 (10 Pin Rule) will NOT be applied.

Rule 319D & Rule 319E will be in effect for all bowlers.

It shall be bowler's responsibility to verify the accuracy of their average. Failure to use the proper average or make corrections prior to or at time of bowling shall disqualify score if the submitted average is lower than actual average or base prize winnings on the submitted average if it is higher.

4. PAYBACK RATIOS

All prize money will be returned 100% as follows:

Handicap Team, Doubles, Singles – 1 for 4

Handicap All Events – 1 for 10

Optional Scratch Events – 1 for 6

5. DIVISIONS / SCRATCH / HANDICAP

DIVISION 1

Team Event Team Average 786 & Over
Scratch 1050 – 90% Handicap – No Limit

Doubles Event Team Average 315 & Over
Scratch 420 – 90% Handicap – No Limit

Singles & All Events Individual Average 158 & Over
Scratch 210 – 90% Handicap – No Limit

DIVISION 2

Team Event Team Average 785 & Under
Scratch 800 – 90% Handicap – No Limit

Doubles Event Team Average 314 & Under
Scratch 320 – 90% Handicap – No Limit

Singles & All Events Individual Average 157 & Under
Scratch 160 – 90% Handicap – No Limit

6. PARTICIPATION

Team Event – May bowl TWICE, with a change of at least TWO players.

Bowler's first score in the Team Event shall be used for their All Events.

Singles & Doubles – May bowl only ONCE.

Bowlers must bowl in both Singles and Doubles.

There will normally be 3 sets of doubles per pair of lanes. Doubles will be bowled first followed by the Singles.

If a bowler is late for the doubles event, the bowler present will bowl singles first. If the partner has not arrived when the singles has completed and a qualified substitute is not available, the bowler may compete in the doubles alone to qualify for the all events.

All three games of an event will be bowled on the designated lanes for that event.

7. SUBSTITUTIONS

Lineups as submitted on entry blank must be adhered to, unless notification is received 48 hours prior to competition. A substitute must bowl in the position vacated. Scores bowled through the efforts of more than one person will not qualify for any special individual awards.

Bowlers failing to appear at scheduled time and are unable to be rescheduled will forfeit their entry fees.

8. OPTIONAL EVENTS

A. OPTIONAL HANDICAP ALL EVENTS

The entry fee must be paid prior to an entrant's FIRST participation in the tournament.

B. OPTIONAL SCRATCH EVENTS

The entry fee must be paid prior to an entrant's FIRST participation in the tournament.

Prize winnings will be based on ACTUAL scores.

Doubles entries remain with Entry # & Pair # regardless of substitutions.

C. BRACKETS

Individual Handicap Brackets in each of the Events.

9. AWARDS

Awards and Complementary Dinners at the Banquet of Champions, (for each individual champion and a guest) will be presented to the:

in Each of the Events (Div. 1 & 2)

(Team, Doubles, Singles, All Events)

BERTHA McBRIDE Award

(High Actual Game in the Team Event)

VIRGINIA PECHACEK Award

(High Actual Series in the Team Event)

10. OTHER ITEMS

Any tournament game or frame(s) irretrievably lost due to the malfunction of an automatic scorer may be re-bowled, upon approval of tournament management.

Violation of any USBC or tournament rules will result in forfeiture of entry fees and prize winnings.

The St Paul USBC Association will be responsible for refund of entry fees only in the event the tournament is prematurely terminated due to causes beyond its control. Prizes will be pro-rated based on the number of participants that have bowled as of that date.
