- 1) This tournament is open to all St. Paul USBC Members.  
Non USBC members may purchase a USBC Associate Membership for \$16.00.  
Non St Paul Members may purchase a St Paul Membership for \$5.00 (plus \$1 State fees if applicable).
- 2) **Entry Fee = \$75.00.** No refunds of entry fees. All prize fees are returned 100%.
- 3) Entries will close after the first 128 paid entries are received.
- 4) A paid entry becomes the property of the bowler.
- 5) **SATURDAY ....** Squad times are **9:00 AM** and **12:30 PM.** (Everyone bowls on both squads).  
**SUNDAY .....** Semifinal squad starts at **9:00 AM.**  
Match play starts at **NOON**
- 6) All entrants will qualify with 2-four game blocks on Saturday.  
The top 32 will advance to the semifinals on Sunday to bowl another four game block.  
The top 16 bowlers will advance to the Match Play finals.  
A 1 game rolloff will determine the winner of any ties for either 32nd place on Saturday or 16th place on Sunday. A 9th and 10th frame will be bowled if a tie still exists.  
The Match Play finals are a double elimination format with the winners decided by a two game total pinfall. A 9th and 10th frame rolloff will determine the winner of any ties.
- 7) The USBC rule prohibiting use of any abrasive on the surface of the bowling ball during competition **WILL BE ENFORCED** with immediate disqualification and forfeiture of entry fee.
- 8) **NO ENTRIES ARE RESERVED WITHOUT ENTRY FEES.**
- 9) There will be \$10 brackets conducted during all qualifying competition.  
A portion of the bracket proceeds will be donated to various St. Paul Youth Scholarship Programs and the Prize Fund.
