COMPOSITE TEAM AVERAGE MUST NOT EXCEED 950.

Team lineups **MUST** be either 2 Men/3 Women or 3 Men/2 Women
Handicap shall be 90% of (950 – Team Average) divided by 5. No Limit.

Entry Fee \$125.00 per Team

All bowling will be done using the exciting 'BAKER' style format!
The baker style uses all 5 players scoring in the same game.
(The leadoff bowler rolls frames one and six, the 2nd bowler rolls frames two and seven, etc.)

AVERAGE RULES

Entering averages will be previous season's highest sanctioned average, minimum of 21 games. Bowlers without a previous season's average, will use their current season's average as of December 1st, minimum of 21 games. Any bowlers not having a previous season's average or current average is not eligible to compete.

QUALIFYING COMPETITION

All teams will bowl 10 games. Lane assignment will be made by lottery draw.
Top 8 teams based on total score (pinfall+handicap) will advance to Match Play Competition.

MATCH PLAY COMPETITION

The Qualifying Competition score will be carried forward.
Teams will be assigned #'s 1 thru 8 based on Qualifying Competition score.
An 8-team schedule will be used for pairings and lane assignments.
Two game matches will be bowled against each opponent plus a final position round.
15 Bonus points will be awarded for each game won.
20 Bonus points will be awarded for each match won.

TITLE MATCH COMPETITION

The top 3 teams based on total score (Qualifying, Match Play and Bonus Points) shall advance to the Title Play.
The three finalists will bowl two game matches. Total score (pinfall + handicap) will determine the winner.

SEMI-FINAL MATCH – Third place team bowls the second place team.

The winner will advance to the Final Match. Loser receives third place prize.

TITLE MATCH – Winner of the Semi-Final match bowls the tournament leader.

Winner receives Champions awards, Loser receives 2nd place prize.

13TH ANNUAL MIXED LIMITED AVERAGE TEAM CHALLENGE

Tournament Rules

1. **ELIGIBILITY** - ALL bowlers must be USBC certified, and members of the Minneapolis or St Paul Bowling Associations.
2. Team lineups are limited to 5 players.
There must be 2 Men/3 Women or 3 Men/2 Women on each team.
Captain may replace any player with a qualified substitute at any time.
A player removed from competition, may not return.
Entrants may participate with only one team in the tournament.
3. All prize fees will be returned 100% on a 1 for 3 ratio.
4. Teams will receive lane assignment at check-in time.
Teams will bowl 1st game on drawn lane, 2nd game on alternate lanes.
After each 2nd game, teams starting on the odd lane will move left and teams starting on the even lanes will move right.
5. If a tie exists for 8th place at the conclusion of Qualifying Competition, teams will bowl an additional game to break the tie.
If a tie still exists, ninth and tenth frame roll-off will be bowled until the tie is broken.
6. In the event of a tie, to determine positions one thru seven for placement in the Match Play Competition, the last Qualifying game bowled will be used to break the tie.
If a tie exists for that game, previous game scores will be used until a tie breaking score is found.
7. If a tie occurs during the Title Play, a five frame roll-off will be bowled, scored as frames six thru ten, until the tie is broken.
8. Tournament Management will determine the lanes to be used for all competition (scheduled and/or tie breaking).
All tie breaking competition WILL NOT be included in total pinfall.
